### **ELIGIBILITY HEARINGS**

### Riverview - Shyran Glover

After reviewing the information and testimony presented the WPIAL Board of Control Hearing Panel granted Shyran Glover a period of participation waiver under Article VIII, Section 6 of the PIAA By-Laws.

#### **BELLE VERNON ~ Baseball Coach Behavior**

After considering the information and testimony presented, the BOC Hearing Panel determined the following: 1) Coach Hixenbaugh is publicly censured for his inappropriate comments to the media concerning WPIAL/PIAA baseball officials. Such comments to the media cannot and will not be tolerated. 2) The probationary period for Belle Vernon will be extended by one year through the 2016 baseball season UNLESS the Belle Vernon Area High School Administration: a) suspends Coach Hixenbaugh from coaching and attending the first two (2) regular season Belle Vernon boys baseball games during the 2015 PIAA baseball season; and b) requires Coach Hixenbaugh to enroll in and successfully complete an ACEP (American Coaching Program) containing some sort sportsmanship component by July 1, 2014. On or before June 1, 2014, the Belle Vernon Area High School Principal must verify in writing to WPIAL that Coach Hixenbaugh has enrolled in such an ACEP. On or before July 15, 2014, the Belle Vernon Area High School Principal must certify in writing to WPIAL that Coach Hixenbaugh successfully completed such an ACEP.

#### 2014-15 BUDGET APPROVED

The WPIAL Budget Committee developed and approved a preliminary budget at planning meetings in May, 2014. Following discussion and modification, the WPIAL BOC adopted a \$1,841,900 operating budget for the year ending June 30, 2015. The operating budget represents a \$43,729 increase from the 2013-14 operating budget.

The 2014-15 budget includes the following:

- To maintain the dues at \$150 for high schools and \$50 for junior high schools.
- Revises the revenue share program for soccer, football and basketball to \$200,000.
- To maintain ticket prices in all tournament events.

#### **COOPERATIVE SPONSORSHIPS APPROVED**

### <u>Hopewell – Aliquippa</u>

The BOC conditionally accepted the request of Hopewell High School and Aliquippa High School to form a

cooperative sponsorship of a sport agreement in boys' and girls' soccer beginning with the 2014-2015 school year with Hopewell as the host school. The conditional acceptance is based on the fact that the combined enrollments do not change the assigned classification. The request was forwarded to the PIAA for their final approval.

### EIGHTH ANNUAL HALL OF FAME INDUCTION CEREMONY

### SOCCER/LACROSSE CHAMPIONSHIPS TO HIGHMARK STADIUM

The WPIAL and the Riverhounds Event Center have finalized an agreement for the 2013-14 WPIAL soccer and lacrosse championships to be held at the new Highmark Stadium located in the Station Square complex of Pittsburgh. All six soccer championships (three boys and three girls) will be contested on November 1 and 2, 2013. Two games will be played on Friday, November 1 and four games on Saturday, November 2. The four lacrosse championships (2 boys and 2 girls) will be contested on Thursday, May 22 with 2 girls champinships and Friday, May 23 with the 2 boys championships.

### WPIAL 2014-2015 & 2015-2016 BASKETBALL CHAMPIONSHIP SITE

The BOC approved a two year contract with the University of Pittsburgh to host the 2014-2015 and 2015-2016 basketball championships. RFP's were submitted by three venues. Each of the proposals submitted was analyzed with respect to all factors, including, seating capacity, parking, handicapped accessibility, hospitality, spectator and media accommodations, staffing and cost.
