

## WPIAL RIGHTS FEE SCHEDULE

### A. BROADCASTING /WEBCASTING (AUDIO)/REAL-TIME PUBLISHING RIGHTS FEE SCHEDULE

#### 1. Football (per game)

All Classes	Radio Broadcast, Webcast (Audio Streaming), or Real-Time Web Publishing Rights Fee
Preliminary Rounds*	\$ 300

#### 2. Basketball (per game)

#### 3. Baseball / Soccer / Softball/Volleyball /Lacrosse/Field Hockey/ Wrestling (Team and Individual) (per game)

All Classes	Radio Broadcast, Webcast (Audio Streaming), or Real-Time Web Publishing Rights Fee
Preliminary Rounds*	\$ 300

\*-Preliminary rounds includes pigtail, first round and quarterfinal round games. Semifinal and Final round games are not available.

### B. CABLECASTING/TELECASTING/WEBCASTING RIGHTS FEE SCHEDULE

#### 1. Cablecasting/Telecasting/Webcasting (Video) - Football

## 3. Baseball / Soccer / Softball/Volleyball /Lacrosse/Field Hockey/ Wrestling (Team and Individual) (per game)

### C. School District/Community Access Telecasting

The rights fee for events telecast by a school-owned television station or a community access channel on a cable network will be 25% of the cablecasting/telecasting/webcasting fee for delayed transmission, provided the following conditions are met:

1. The production crew consists of students under the direction of an adult sponsor.
2. The telecasting of the event is on a delayed basis only a minimum of 24 hours after the starting time of the event.
3. The event must be televised at no charge to viewers only over the school-owned station or community-access channel in the community of the member school participating in the event.
4. The telecast/cablecast/webcast can not include commercials.

The rights fee for a live telecast of an event by a school-owned television station or a community access channel on a cable network will be 100% of the fee specified in Section B – 1, 2, and 3 above.
